## ELIGIBLE VEHICLES

- **Class A**, passenger cars
- **Class M**, multi-purpose vehicle
- **Class EFT**, (Agricultural plate only)
- **Class EPO**, trucks up to 1 ton (up to 26,000 lbs.)
- **Class G**, trailer
- **Class B**, for hire

Vehicles with plates for individuals with disabilities or personalized plates can obtain Bay or Agricultural plates. 7 character personalized plates will not include the blue heron.

## WHAT TO DO

1. Complete and sign the application. A separate application and fee are needed for each set of plates.
2. To receive Chesapeake Bay or Agricultural Plates in person, take a completed application and \$20 fee to a full-service MVA office. Or, mail a completed application and \$20 check or money order to the MVA and plates will be mailed to you.  
*(Please note: Plates have a \$5 per year renewal fee.)*
3. If renewing registration at the same time, include your renewal notice and registration fee.
4. Make check payable to MVA. Checks must include imprinted name and address, driver's license number (soundex number), and home and/or work phone number.
5. On receipt of your Bay or Agricultural Plates, immediately return the license plate(s) presently on your vehicle to any MVA office for cancellation.
